<b>Children of Minister's Discount</b>	\$3,000 per year	Any admitted freshman student	Students entering Rochester Christian University as freshmen who are dependent children of full-time ministers (pulpit, youth, worship) or foreign missionaries (working under the supervision and support of a Christian Church in the United States. A letter from the supporting congregation required annually) and who have served in that capacity for at least 3 years. A letter from your home congregation must be submitted annually.	n/a	2.0
<b>Christian Academy/School Graduate Discount</b>	\$5,000 per year	Any admitted freshman student	Awarded to students entering Rochester Christian University as a freshman who graduated from a Christian High School.	n/a	2.0
<b>Family Tuition Discount</b>	\$2,500 per year per student	Any admitted freshman student	Awarded automatically if two + dependent children, a parent and child, or husband & wife are concurrently enrolled full-time.	n/a	2.0
<b>Warrior Legacy Scholarship</b>	50% of tuition up to five years	Any admitted freshman student	At least one parent must have earned at least 24 credit hours and attended a full academic year at RCU. <b>(Not stackable with other scholarships or discounts)</b>	n/a	2.0
<b>Transfer, Phi Theta Kappa and First Generation Scholarship may be awarded in addition to other RCU discounts.</b>					
<b>First Generation Student</b>	\$1,000 per year	Any admitted freshman student	Neither of the student's parent or guardian has completed a college or university degree	n/a	2.0
<b>Transfer Scholarship</b>	\$3,000 per year	Any admitted transfer student	Awarded to students entering RCU as a transfer student	n/a	2.0
<b>Phi Theta Kappa Scholarship</b>	\$2,500 per year	Any admitted transfer student	Awarded to students who are members of the Phi Theta Kappa Honor Society	n/a	2.0

Only full-time students (minimum of 12 semester hours) are eligible for institutional aid. Students who dual-enrolled during high school or completed Early College programs will still be eligible for freshman scholarships as long as they earned 60 credits or less.
